American Rescue Plan (ARP) - Student Emergency Assistance Grants July - September 2021 Report

This report contains information that is required by the U.S. Department of Education (Ed).

Hamline's President, Fayneese Miller, signed and the University returned to Ed the Certification and Agreement document with the assurance that the University has and will expend awarded funds as designated to provide Emergency Financial Aid Grants to Students.

- Subsequently, Hamline University received an award from Ed on April 22, 2020 in the amount of \$1,285,114 in accordance with the Coronavirus Aid, Relief, and Economic Security Act (CARES) to provide emergency financial aid grants to students. These funds have been fully distributed to 1,360 students.
- In addition, Hamline received a supplemental award from Ed on December 27, 2020 in the amount of \$1,285,114 in accordance with the Coronavirus Response and Relief
 Supplemental Appropriations Act (CRRSAA) to provide additional emergency financial aid grants to students. These funds have been fully distributed to 852 students.
- Finally, Hamline received a second supplemental award from Ed on May 19, 2021 in the amount of \$3,485,600 in accordance with the **American Rescue Plan** (ARP) to provide further emergency financial aid grants to students.
- Therefore, Hamline University has received \$6,055,828 in total from Ed to provide emergency financial aid grants to students.

Regarding American Rescue Plan (ARP) funds, as of September 30, 2021, the last day of the third quarter, the total number of students at Hamline determined to meet the institution's standards for eligibility to receive an emergency financial aid grant is 3,139.

In addition, as of September 30, 2021, 714 current or former students who had responded to our broad invitation to complete a brief emergency grant application had reported a pandemic-related financial impact. These individuals have received grants totalling \$719,278.

At this time, plans are being finalized to distribute the remainder of the ARP funds, one this fall

and one later in the academic year, to current domestic undergraduate students with "exceptional need" based upon AY2022 Pell grant eligibility, expected family contribution amount, and enrollment percentage.

The following table presents the anticipated expected family contribution (EFC) categories, number of students expected in each to receive an ARP grant, and award amounts for the fall semester 2021 distribution of ARP funds to students.
